
**ORDER CLARIFYING VISITATION RULING**

On April 8, 2025, this Court considered the Motion for Clarification filed by Steven John Donahue, Movant pro se, regarding the April 7, 2025, oral ruling restoring visitation with Linda Lefebvre Donahue, effective immediately, pursuant to Neb. Rev. Stat. § 30-2613.

IT IS HEREBY ORDERED:

1. The April 7, 2025, oral ruling restoring Movant's visitation rights with Linda Lefebvre Donahue is effective immediately as agreed, as pronounced in open court and binding under Neb. Rev. Stat. § 25-914.
2. Visitation shall be conducted strictly according to Prestige Care Center's Rule Book, including but not limited to: no guns, no alcohol, no drugs, no homemade meals, no involvement in Physical Therapy or medical care, no rude or disruptive behavior, no recordings, and Prestige's right to search Movant.
3. Prestige Care Center shall provide Movant with its Rule Book forthwith.
4. Any disputes or bans arising from rule violations shall be resolved between Movant and Prestige Care Center, not involving Carol Lefebvre Toto or Kathleen Pallesen, Esq., as agreed.
5. No additional safety plan or signed order beyond this clarification is required for Movant to exercise his visitation rights as of April 8, 2025.
